1. The UG programs are for four years duration as per the new NEP policy.
2. The Entrance examinations includes written test and Interview which will be held **offline** for all the Programs (UG, PG, and MD).
3. Application fee for the Entrance examination:  
For Indians and SAARC nations: Rs. 1,000/ application.  
For Foreigners: USD 30.
4. Separate applications should be submitted for each course. To help the students from different parts of India, the entrance exam will be conducted on two different dates. Student can choose any one the dates. The tentative entrance examination schedule is as follows:
  - a. **Entrance Exam: 24<sup>th</sup> Jun and 22<sup>nd</sup> July, 2023**
  - b. **Reporting time for the Written Test 10 AM. This will be followed by an Interview on the same day.**
5. The results of entrance exams will be announced on 24<sup>th</sup> July.  
Those who are selected in the admission process, should get admitted to the course on or before 30<sup>th</sup> July, 2024 by paying course fees for first semester.
